# 2026 EMPLOYMENT NOTIFICATIONS BOOK AND LAMINATED POSTERS

UPDATED for 2026! FELS California Employment Notifications Book and federal Laminated Posters.

**FELS California Employment Notifications book and federal Laminated Posters** contain the primary state and federal notices you must post for employees, many in English and Spanish, side by side. The California Notifications Book measures 11 x 17 inches; each poster measures 27 x 38 inches. Other posters are available to meet other specific requirements described below; see full listings of postings on each poster on the order form on the reverse.

**NOTE:** Guidance from the United States Department of Labor indicates that federal agencies expect all notices mandated by those agencies to be in the form of posters to be hung on a wall, a sheet of plywood affixed to a toilet trailer or heat illness shelter trailer or otherwise physically posted and that putting federally-required postings in any sort of book or binder is not acceptable for the purpose of fulfilling federal posting requirements. Guidance offered by the California Department of Industrial Relations indicates that books or binders will continue to be acceptable to furnish employees access to state-required postings.

To fulfill the federal posting mandate, FELS has re-designed the Employment Notices Book & Posters product to shift all federal postings to physical, wall-hung posters. California-required postings will continue to be available in book form and you may purchase a California Employment Notifications book with laminated posters that will include all federally-mandated postings (Kit #1).

Alternatively, you may purchase five posters that include all federal and state postings (Kit #2). Postings will continue to be offered side-by-side in English and Spanish.

**Notifications Posting Kit #2** includes all contents of Notifications Kit #1 (all federal and CA employment notifications) on five laminated posters:

**California Department of Pesticide Regulation Form A-8 (Handler Safety) and A-9 (Farmworker Safety) (English & Spanish):** includes CA Pesticide Safety Information Series (PSIS A 8 & A-9) – English & Spanish: Must be displayed at work locations and used in fieldworker and handler training. This poster is not included in Kit #1 or Kit #2 and must be ordered separately.

**Note:** Employers of 5 or more employees must post Your Rights and Obligations as a Pregnant Employee (CRD-E09P-ENG) and Family Care and Medical Leave CFRA (CRD-100-21ENG). The FELS 2026 Employment Notices posters and book furnish both notices; please mark through CRD-100-21ENG with a black felt tip marker if you employ fewer than 5 employees.

In addition to these notices, agricultural employers might also need to post:

**IWC Order #4 (Professional, Technical, Clerical, Mechanical and Similar Occupations):** This posting is available for free download. In agricultural operations, the following types of employees are among those covered by IWC Order #4: accountants, bookkeepers, carriers, cashiers, computer programmers and operators, dispatchers, guards, guides, laboratory and research workers, salespersons and secretaries.

**IWC Order #8 (Industries Handling Products After Harvest):** This posting is available for free download and covers operations handling products after harvest, at least some of which were not grown or otherwise produced by the employer. It typically covers commercial establishments that clean, dry, sort, pack, dehydrate, slaughter, ferment or pasteurize a commodity. Order No. 8 covers the office and transportation employees of such an employer.

**IWC Order #13 (Industries Preparing Agricultural Products for Market, on the Farm):** This posting is available for free download and covers operations engaged in an industry preparing on a farm, agricultural products for market. It typically covers an employer's employees who prepare for market, in either a fixed structure or on a moving packing plant on a farm, commodities grown or otherwise produced by that employer only, plus the employer's clerical employees and those who transport the commodities to market.

**Additional Information about FELS Employment Notifications Book and Laminated Posters**

**Human Trafficking / Slavery Notice (included in Kits #1 & #2):** Specified types of businesses must post a notice urging the reader to report instances of slavery and human trafficking. Among those types of businesses are farm labor contractors. The notice must be posted conspicuously near the establishment's public entrance or elsewhere conspicuously where similar notices are customarily posted. The notice must be printed in English, Spanish and one other language that is the most widely spoken language in the county where the establishment is located and for which translation is mandated by the federal Voting Rights Act. Printed on glossy cardstock.

**Farm Labor Contractor Rate of Compensation (included in Kits #1 & #2):** CA-licensed farm labor contractors must prominently display at the worksite and on all vehicles used to transport employees the rate of compensation printed in English and Spanish. Laminated Poster. (Labor Code section 1695, subd. (a)(7).)
